Consent Statement

- The ID-card must be visible at all times when inside the port area**
- IF you pass through the gate with a vehicle, the vehicle must have valid a vehicle sticker placed on the left side of the windshield.
- It is **YOUR** responsibility to ensure that no one else passes through without using their own ID-card. Violation of this will lead to confiscation of ID-card and / or restricted access rights.
- If you observe any suspicious objects or behaviour inside the harbour area, you must immediately notify the security gate.
- All passengers in the car **MUST** be registered at the gate, and pass through the revolving gate.
- The Port of Drammen reserves the right to change the individual user's access rights without notice, as well as closing the selected access points to the port facility when needed.
- All traffic on the pier is for authorized personnel only.
- It is strictly forbidden to use private cars inside the port facility area. Only vehicles with valid stickers may pass.
- The ID-card with associated code is strictly personal, and will be confiscated if misused.
- High visibility warning clothing class 3 **MUST** be used when you are within port facility area.
- Helmet **MUST** be used at any given time where there is a specific Helmet Zone.
- If you are delivering outgoing cargo, the form 2.8.7 ISPS – Sjekkliste ved innlevering av gods must be handed to the gate before entering.
- There is a charge for lost or damaged ID-cards.
- The card must be submitted to the Port of Drammen when the contract or employment is terminated. If the port of Drammen does not receive a cancellation of the access card before the turn of the years in the current year, an invoice for the next year will be issued automatically.
