Consent Statement: <ol style="list-style-type: none"> <u>All vehicles must have valid vehicle sticker</u> when driving in the port area. The sticker should be placed clearly visible on the windshield to the left. The sticker is specific for the assigned vehicle. Vehicles without a valid sticker will be asked to leave the area/towed away at the owner's expense and personal ID-card will be blocked. <u>The ID- card must be visible at all times when inside the port area</u>. You are obliged to report to the Port of Drammen of personnel and vehicles without a valid sticker/ID-card in this area. The ID-card with associated code is strictly personal, and will be confiscated if misused. When you are passing through the gate with the vehicle, it is YOUR responsibility to ensure that no passengers are passing through the gate without using <u>their own ID-card</u>. Violation of this will lead to confiscation of ID-card and / or restricted access rights. All passengers in the car MUST be registered in the gatehouse and pass through the revolving gate. If you see suspicious objects or suspicious behaviour inside the harbour area, you must notify the security gate immediately. The Port of Drammen reserves the right to confiscate the driving permission, and the right to change the individual user's access rights without notice, as well as closing the selected access points to the port facility when needed. All traffic on the pier is for authorized personnel only. High visibility warning clothing class 3 MUST be used when you are within port facility area. Helmet MUST be used at any given time where there is a specific Helmet Zone. If you are delivering outgoing cargo, the form 2.8.7 ISPS – Sjekkliste ved innlevering av gods must be handed to the gate before entering. There is a charge for lost or damaged vehicle sticker. The vehicle sticker must be submitted to the Port of Drammen when the contract or employment is terminated.
